## Round One Interviews for the Position of Superintendent of Schools

Dr. Randy Liepa of Michigan Leadership Institute (MIL) gave a brief update on the steps on the posting for a Superintendent. There was an electronic survey along with 2 open community forums. The job posting was Clarenceville specific based on community feedback. There were 22 candidates, the Board selected 7 for interviews and one candidate withdrew. Community members in attendance were given the opportunity to fill out candidate comment sheets and were collected after each candidate's interview.

- Dr. Julie Kaminski, Instructional Coach, Clarenceville Schools

Board reviewed community comments from tonight's interviews. After comments were reviewed Dr. Liepa explained the next steps. In round robin fashion each board member gave a brief summary of what they felt was each candidates pros/cons. After all the candidates were discussed, Dr. Liepa asked each board member to select their candidates to bring back for a second interview. Discussion was held to bring each candidate in for a site visit. Was decided due to the timing of the second interview and last day of school that this currently would not be possible.
